



There have been many activities throughout the county this year celebrating our pioneers, and historical places, so lets celebrate December 2025 and to out with a bang!

- * Indian River County 1925 Until this time Vero was part of St. Lucie County. A desire for local autonomy moved legislators to push for the formation of a new county. In May 1925 Indian River County was born, Vero became the county seat, with the name officially changed to Vero Beach in 1925. The Dixie Highway was officially open for traffic in October 1925. This was a new highway for the burgeoning auto industry that ran from the Canadian Border at the northern tip of Michigan to Tallahassee and Jacksonville, and proceeded south along the east coast through Vero Beach to Miami. In December 1925 the Vero Beach Journal newspaper began publication.
- * Garden Club of Indian River County, Inc. Has chosen December 2025 to correlate historical places and festive events throughout the last century in Indian River County. Garden Club of Indian River County annual Christmas Ornaments and various headlines of interest highlight a sense of our local history, horticulture, and environment to celebrate our past, present, and future.

General Rules

- 1. This Standard Flower Show conforms to the standards established by the National Garden Clubs, Inc. (NGC). The handbook for Flower Shows (HB), 2017 2nd Edition, revised July 2024, is the authority for all issues not covered by the schedule, which is the Law of the Show.
- 2. All Divisions are open to all NGC, Inc. members or by invitation.
- 3. Advance Registration is required for all entries. See specific registration instructions in each Division.
- 4. Registration begins March 26, 2025. Registration deadline for all entries is Saturday, November 1, 2025
- 5. Schedule and Entry Forms will be available Wednesday, March 26, 2025 via email, GCIRC website, or printed at the GCIRC clubhouse.
- 6. Entry cards will be provided by the Division Chairs at the time of placement of the entry.
- 7. Exhibitors are required to bring registration forms at the time of entry staging.
- 8. Entries will be accepted at the Vero Heritage Center as follows:
 - Divisions I & III, Friday December 5, 2025, 10 a.m. to 4 p.m.
 - Division II & IV (except photography), Friday December 5, 2025, 10 a.m. to 4 p.m. an Saturday December 6, 2025, 7 a.m. to 8:30 a.m.
 - Judges, all divisions Friday, December 5, 2025, 10 a.m. to 4 p.m. and Saturday December 6, 2025, 7 a.m. to 8:30 a.m.
 - Photography 1 week before the show, or by 1 p.m. Friday December 5, 2025
- 9. All entries must be removed between 4 p.m. and 5 p.m. on Sunday, December 7, 2025.
- 10. The Classification Chair for each division check exhibits for conformity to the schedule prior to judging. Final determination for conformance is the judges' responsibility.
- 11. All exhibitors must leave the show area by 9 a.m. December 6, 2025.
- 12. Judging will begin at 9:30 a.m. on Saturday, December 6, 2025. Judging will be done by NGC Accredited Judges.
- 13. The General Chair and the Classification Chairs for each division are available during judging for possible consultations. They, along with the Judges and Clerks, are the only personnel allowed on the floor during judging.

General Rules (continued)

- 14. The decisions of the judges are final. Awards may be withheld if not merited.
- 15. The NGC Standard System of Awarding will be used in all Divisions. Judging is done using Scales of Points based on perfection (100 points). All exhibits will be judged competitively to these standards. Scales of points for all competitive exhibits are found in the *Handbook for Flower Shows, Revised 2017 2nd Edition, revised July 2024*, Chapter 14.
- 16. There must be an emphasis on FRESH plant material; no artificial plant material is permitted in any exhibit in any Division.
- 17. Each exhibitor is limited to one entry per class, except in Horticulture Division, and the Botanical Arts Horticulture Section. Exhibitor may make more than one entry per horticulture class if each is a different species, variety, cultivar, type or color.
- 18. The Garden Club of Indian River County will strive to assure the safety of all items after arrival and placement, but is not responsible for any loss or damage to exhibits.
- 19. Native plant material may be entered if correctly labeled and legally obtained within the State of Florida. The use of plant materials on Florida's Federally Listed Plant Species as endangered or threatened is prohibited. Refer to: https://www.fdacs.gov/Consumer-Resources/ProtectOur-Environment/Botany/Florida-s-Endangered-Plants.
- 20. The use of plant material classified as Invasive Exotic or Aquatic Invasive is prohibited. For a complete list, see IFAS web site a Center for Aquatic and Invasive Plants: https://plants.ifas.ufl.edu/

Awards

The NGC Standard System of Awarding (HB pages 5, 25) will be used in all divisions.

- Only one (1) first place (blue) ribbon per class or subclass; must score 90 points or more.
- Only one (1) second place (red) ribbon per class or subclass; must score 85 points or more.
- Only one (1) third place (yellow) ribbon per class or subclass; must score 80 points or more.
- One or more honorable mention (white) ribbons as merited; must score 75 points or more

Award must be withheld if the exhibit does not meet the point value for the ribbon.

The following National Garden Club Top Awards, and non-NGC Top Awards will be awarded, if merited, to the highest scoring blue ribbon winners scoring 95 points or more. (See "Awards" Chapter 5, HB pages 39-40, in the 2017 NGC *Handbook for Flower Shows Revised 2017 - 2nd Edition, Revised July 2024* for all award requirements.)

Division I - Horticulture "CENTURY IN BLOOM: INDIAN RIVER COUNTY'S HORTICULTURE LEGACY"

Horticulture Rules

- 1. The NGC exhibit policies are printed in the *Handbook for Flower Shows*, revised *2017- 2nd Edition*, *revised July 2024*, Chapter 6, page 55-56, Exhibiting in The Horticulture Division.
- 2. The rules for single species, cut or container-grown specimens are listed in the *Handbook for Flower Shows* or its supplement, *Horticulture Exhibiting and Judging.*
- 3. Horticulture classes are open to all members of NGC, Inc., and by invitation.
- 4. All exhibits must be fresh and have been grown by the exhibitor.
- 5. Plant material must be in its natural state and may not be altered by application (treatment) of oil, commercial "shine" products, etc. that change the natural appearance. No wiring of specimens is permitted.
- 6. In order to receive an NGC top Exhibitor Award, the exhibitor must identify the entry by its binomial name or currently acceptable scientific designation.
- 7. Each exhibitor in Division I Horticulture will be limited to 5 entries per Class, if the exhibits are different species or hybrid.
- 8. Hanging plants are permitted in all Division I.
- 9. Schedule and Entry Forms will be available on Wednesday, March 26, 2025. Pre-registration begins on Wednesday, March 26, 2025, by sending form to Horticulture Entry Chair: Missi Boyd, missiboyd@gmail.com or Kim Zimmerman kimvinot@gmail.com. Deadline for entries is Saturday, November 1, 2025.
- 10. Horticulture Specimen Delivery Time Friday, December 5, 2025, 10:00 a.m. to 4:00 p.m.. Out of town Judges by appointment only, on Saturday, December 6, 2025, by 8:30 a.m.
- 11. Entries must be accompanied by a copy of the entry form.
- 12. The Horticulture Classification Chair will provide the Entry cards at the time of entry placement based on entry form information.
- 13. Size of container is limited to approximately 24" in any direction, except Section E, which may be up to 36". Large entries must be placed by exhibitor.

14. All plant material must have been in possession of the exhibitor for the appropriate number of days listed as follows:

Combination Plantings - 6 weeks growing together Annuals, bulbs, houseplants, perennials - 90 days

- 15. Displays and Collections in Section F include a minimum of five different specimens exhibited in individual containers, or the appearance of being individually exhibited. The space allotment is limited to 24 inches wide, 24 inches deep, and 36 inches tall for cut classes. Container Grown Classes space allotment to be adjusted based on specimen size and committee agreement, but not to exceed 48 inches in width.
- 16. Cut specimens should not have foliage below the water line.
- 17. Foliage plants may flower, but should be exhibited as foliage plant if they are grown for their leaves. With the exception of Bromeliads and Orchids, which will be considered in their own Sections with both foliage and blooming specimens.
- 18. More than one plant of the species may be exhibited in the container as a single specimen. Including: Self-multiple plants (multiple shoots arising from the same root system) or Multiple plantings more than one plant of the same cultivar and color combined in the container to improve the overall appearance of the planting.
- 19. The Horticulture Classification Committee Chair and/or General Show Chair are free to subdivide classes by color, form, size, cultivar, variety, or other distinguishing characteristics.
- 20. The Scale of Points is located in the Handbook for Flower Shows, Revised 2017-2nd Edition, revised July 2024, Chapter 14, page 129-130.

Beginning Wednesday, March 26, 2025, contact Design Chair, Patty Prange pattyposies@bellsouth.net Deadline: Saturday, November 1, 2025.
- 3. Plant material and non-plant material permitted and not permitted; are printed in the *Handbook for Flower Shows*, *revised 2017-2nd Edition*, *revised July 2024*, Chapter 7, pages 80-81.
- 4. The exhibitor is required to confirm to the stated description and limitations of the Design Type named in the class.
- 5. Rules for Design Types, Advanced Design Types, Table Designs and Table Appointments are printed in the *Handbook for Flower Shows*, revised 2017-2nd *Edition*, *revised July 2024*, Chapter 7.
- 6. All plant material used in the design must be identified on a 3" x 5" white card, provided by the exhibitor and included with the entry tag.
- 7. The Scale of Points for Design is listed in the *Handbook for Flower Shows*, *revised 2017-2*nd *Edition*, *revised July 2024*, Chapter 14, page 130.
- 8. Pre-registered Design entries may be delivered Friday, December 5, 2025, 12:00 p.m. to 4:00 pm, or Saturday, December 6, 2025, 7:00 a.m. to 8:30 a.m..
- 9. The Design Committee chair will provide the Entry cards at the time of entry placement.
- 10. Entries must be accompanied by a copy of the entry form.
- 11. Designer is on his/her honor that the design being entered has not been previously entered or judged in an NGC Standard Flower Show.

A petite Creative Design not to exceed 6" in any direction. To be staged in a black niche 7" high x 7" wide, X 7" deep, provided by the committee. Displayed 48" from the floor. Designer may provide staging panel and underlay. Designer's choice of plant material.

Class 2. "Children's Games"

4 entries HB pg 73, 75

A petite Multi-Rhythmic Creative Design not to exceed 9" in any direction. To be staged on a 10" x 10" square pedestal provided by the committee. Displayed 42.5" from the floor. To be viewed from three sides. Designer may provide underlay. Designers choice of plant material.

Class 3. "Children's Toys"

4 entries HB pg. 73, 75

A petite Reflective Creative Design not to exceed 10" in any direction. To be staged in black niche 12" high x 12" wide, x 12" deep, provided by the committee. Displayed 48" from the floor. Designer may provide staging panel and underlay. Designer's choice of plant material.

SECTION B: "A Decade of Trains, Planes & Automobiles."

Eligible for Designers Choice Award - HB pg 42

Open to Accredited NGC Flower Show Judge/Student and/or have won a Section Award. This Section is dedicated to advanced design types.

Class 4. "Vero Beach Municipal Airport 2005 Ornament"

4 entries HB pg. 77

A Transparency Creative Design suggesting open space and elements of flight. See-through elements (translucent, diaphanous, grid-like materials) are integral to the design and permitting some components to be viewed through others. Designer's choice of plant materials. May be dried and/or painted. Viewed from three sides. Exhibitors choice of underlay. Size height not restricted. Staged ½ of a 6 foot table, 29 inches from the ground, with black tablecloth. White curtain will be located behind the table.

Class 5. "Vero Beach Railroad Station 1992 Ornament."

4 entries HB pg. 77, 78

An Assemblage three-dimensional abstract design, evoking mechanical power and strength of the track lines and train. The design is made with found unrelated objects and plant material. Designer's choice of plant materials. Staged on ½ of an 6 foot table, 29 inches from the ground, with black tablecloth. White curtain will be located behind the table. Unrestricted height. Objects may be painted. Designers choice of back panel and underlay. Viewed from three sides.

Class 6. "Merrill P. Barber Bridge 1994 Ornament"

4 entries HB pg. 77

An Armature Design incorporating the architecture and structural stability of the bridge. Width of the entry may be up to 36 inches. White curtain will be located behind the table.

Class 7. "Sebastian Inlet 2007 Ornament."

4 entries HB pg. 71-72, 79

An underwater creative design suggesting the innovative influences of open spaces, water and shore. Designer's choice of plant material. Staging provided by exhibitor. Each exhibitor has a 24" square space and exhibit will be viewed from three sides. Designer may provide staging panel and underlay.

SECTION C: "A Hundred Years of Rhythm, Feasts and Heartfelt Toasts."

Eligible for Table Artistry Award - HB pages 43

Class 8. "Charity Ball given at Royal Park Inn, December 1929"

4 entries HB pg. 76

An exhibition table conveying the elegance and jive of the 1929 Royal Park Inn. To be staged on a black open frame 2" deep x 37" high x 25" wide. This frame is mounted on an 18" wide x 12" deep base, and may be incorporated into the design. Frame sits on a black pedestal (24" square top, 40" from the floor, supplied by the committee. Designer may provide staging panel and underlay. Designer's choice of plant material. All staging sits against a white curtain background.

Class 9. "December 24, 1970 - First day of Hanukkah"

A semi-formal functional table for 2 people, celebrating the first lighting of the Menorah. To be staged on a 38" diameter, 29" from the floor, round table. White cloth to ground provided by committee. Designer may provide and use a topper or covering on the table. To be viewed from all sides. Designer's Choice of plant material.

Class 10. "December 1953 - Jr. Garden Club holds Tea and Workshop"

Eligible for GCIRC Novice Award

Open only to Designer's seeking their first Blue Ribbon in a NGC Flower Show

A Functional Tray for one (1) interpreting youth gardeners view of the holiday. Wooden tray will be provided by committee and place on a divided 60" round table with white table cloth. Staged on a tray with interior dimensions 12" deep x 19" wide.

- 2. Education Exhibits may be the work of more than one individual.
- 3. The exhibit must occupy a minimum of 18 square feet surface area.
- 4. Use of plant material is not required, but is encouraged.
- 5. Entries to be staged on $\frac{1}{2}$ of an 8' x 26" table, 29 inches from the floor. Display boards to be provided by the committee, or may be provided by the exhibitor.

Botanical Arts Rules

- 1. All Botanical Arts Horticulture, Design, and Artistic Crafts exhibits must contain some plant material.
- 2. No artificial plant material is permitted in any exhibit
- 3. All Exhibits must be correctly named by the binomial or currently accepted scientific designation.
- 4. The Scale of Points for judging Botanical Arts Horticulture, Design, Artistic Crafts and Photography are listed in Chapter 14 of the *Handbook of Flower Shows*, Revised 2017-2nd Edition, *revised July* 2024.
- 5. The rules for Botanical Arts Horticulture are printed in *Handbook* for Flower Shows, Revised 2017-2nd Edition, revised July 2024, Chapter 10.
- 6. The General Guidelines for all Designs apply as printed in Chapter 7 of the *Handbook for Flower Shows*. A 3" x 5" white card provided by the exhibitor and listing plant material used in the design apply.
- 7. The rules for Photography are printed in the *Handbook for Flower Shows*, *Revised 2017-2nd Edition*, *revised July 2024*, Chapter 10.
- 8. Schedule and Entry Forms will be available on Wednesday, March 26, 2025. Pre-registration begins on March 26, 2025, by sending form to Botanical Arts Entry Chair: Nancy Edmiston, nedmiston@snet.net. Deadline for entry is Saturday, November 1, 2025.
- 9. Entries must be accompanied by a copy of the entry form.
- 10. Pre-registered entries, except photography, may be delivered Friday, December 5, 2025, 12:00 p.m. to 4:00 pm and Saturday December 6, 2025 7 a.m. to 8:30 a.m. Photography can be accepted 1 week before the show, but must be presented by Friday, December 5, 2025 at 1 p.m. Arrangements for early delivery of photography should be made with the Botanical Arts Chair.
- 11. The Botanical Arts Committee chair will provide the Entry cards at the time of entry placement.

Special rules for the three Botanical Arts Sections as follows:

Section A - Botanical Horticulture Special Rules

Class 1 - Dried and/or Preserved Specimens - HB page 92

- 1. Each exhibitor in Class 1, Botanical Horticulture will be limited to no more than 5 entries per sub-class. The exhibits must be different species or hybrid.
- 2. The exhibitor must correctly identify the entry by its binomial or currently acceptable scientific designation.
- 3. The Botanical Arts and/or General Show Chair are free to subdivide sub-classes by color, form, size, cultivar, variety, or other distinguishing characteristics.
- 4. Exhibits must be owned by exhibitor a minimum of 3 months.
- 5. No additional embellishments (dyes, glitter, spray paint or manipulation is permitted. Materials such as Petal-Proof, Super Surface Sealer, or hair spray are permitted to prevent shattering of fragile seed heads, etc.
- 6. Judging is by the Horticulture Scale of Points, the *Handbook of Flower Shows*, *revised 2017-2nd Edition*, *revised July 2024*, page III page 130.
- 7. Exhibits will be displayed on 12" x 18" place-mats provided by the committee at the time of the entry placement.

Class 2 - Container Grown Miniature Fairy Garden - HB page 92

- 1. All types of accessories are permitted.
- 2. Some live plant material must be included.
- 3. The exhibitor must correctly identify the plant material in the entry by its binomial or currently acceptable scientific designation. Plant identification should be on a 3 x 5 white card schematic that accompanies the exhibit.
- 4. Size of the exhibit is limited to up to 18 inches wide or deep, with no limit on height.
- 5. The exhibits will be displayed on an 8 foot table, with black tablecloth 29 inches from the floor.
- 6. Exhibit must be planted together for a minimum of 6 weeks, and be the work of the exhibitor.
- 7. Judging is by the Combination Plantings Scale of Points, the *Handbook of Flower Shows, revised 2017-2nd Edition, revised July 2024*, page 129.

Class 3 - Manipulated Plants - HB page 93

- 1. The exhibit must have been owned by the exhibitor for a minimum of 6 months.
- 2. The exhibitor must correctly identify the plant by its binomial or currently acceptable scientific designation.
- 3. Base of exhibit is not to exceed 18 inches in any direction. Height of plant no more than approximately 40 inches, not including the base. The width of the plant may exceed 18 inches.
- 4. Exhibits to be displayed on 8 foot tables, 29 inches from the floor, with black tablecloth.
- 5. The exhibit may include support structure for the manipulation of the plant. The plant must dominate.
- Authentic bonsai is never judged in an NGC Standard Flower Show.
- 7. Judging is by the Horticulture Scale of Points, the *Handbook of Flower Shows, revised 2017-2nd Ed., revised July 2024*, page 129.

Section B - Botanical Design - HB pg 93-94

- 1. General guidelines for the Design division apply, including a white 3x5 card listing all plant material used in the design.
- 2. All exhibits must contain some plant material.
- 3. No artificial plant material is permitted.
- 4. Fresh, dried, and/or components may be added for embellishment. Non-plant material may be used to embellish. Materials that may be used include fresh or dried foliage, flowers, vines, cones, wood, glass balls, or natural materials such as shells.
- 5. Judging is by the Design Scale of Points, the *Handbook of Flower Shows, revised 2017-2nd Ed., revised July 2024,* page 130.

Section C - Photography

- 1. Velcro will be used to display photography to a panel by committee.
- 2. Total measurement mat and image size shall not exceed 16" x 24'. Image should be matted, and may be over matted. No frames are permitted.
- 3. Images will be hung or displayed vertically for judging.
- 4. All photography must be the work of the exhibitor.
- 5. Photography exhibits can be accepted 1 week before the show, but must be presented by Friday, December 5, 2025 at 1 p.m. Arrangements for early delivery of photography exhibits should be made with the Botanical Arts Chair.
